TEXT PREPARATION 4 – Assignment due in class on March 25 from some students

Please only complete this assignment if you have received your marked first assignment for this class. It is important to take full account of past feedback received in completing a further assignment for this course.

This assignment consists of attendance of the full class session on March 25, plus completing the written assignment below, to be submitted in class on March 25 only.

(*Rationale:* Text Preparation assignments are designed to help you prepare the reading assignment for a particular class meeting, in conjunction with your participation in that class meeting, when we go over the reading selection together.)

If you cannot come to class on March 25, please plan to complete a different Text Preparation assignment for a future date.

This assignment is based on:

- Archbishop of Canterbury, Rowan Williams, “Civil and Religious Law in England: A Religious Perspective” (2008)
- Sherene Razack, “The Muslims Are Coming: The ‘Sharia Debate’ in Canada” (2008) (with knowledge of Anna C. Korteweg, “The Sharia Debate in Ontario” [2006] in the background)

Detailed Instructions: In well-written paragraphs, a total of 600–700 words, please address the following two questions with detailed reference to the text:

1. What does Rowan Williams mean by “plural jurisdiction”? In what ways does he view this concept as key to developing a renewed understanding of the relationship between civil and religious law?
2. Sherene Razack cautions that feminism should not automatically be guided by principles of secularism when considering certain policy questions involving Islam, such as the 2004–5 “sharia debate” in Ontario. What is her main argument for this view? (You may wish to define the terms “feminism” and “secularism” as Razack uses them.)

Please number your answers to the individual questions.

As was the case for the Text Summary assignment, all your observations about the text should be backed up with references that allow your reader to see what they are based on; for this purpose, please use in-text parenthetical page references, as in this sample sentence:

Locke underscores that acts of violence are sometimes perpetrated “upon pretence of Religion” (23).

Please print your assignment double-spaced and with one-inch margins, using an 11–12-point font. Please number and staple the pages you hand in. Please write “Text Preparation 4” at the top, and indicate the total word count at the end.

Note: Since this is your first reading of this text, and since we have not yet discussed it in class, the summary assignment is simply a first effort at figuring out what it says, and doing it will help you get the most of our in-class work on it. The assignment is not evaluated for whether it demonstrates a good understanding of the reading, but for evidence of your having worked in detail to understand the reading. Your fuller understanding will develop in the course of our class meetings, and with successive re-readings.
